- 02 **Cov ntaub ntawv ntsig koj qhov muaj mob hniav tam sim uas koj tus kws kho hniav xa tuaj tsis raug raws li cov tshooj lus kev tso cai rau qhov kev saib xyuas no.**
- 03 Kev thov rau kev kho hniav raug hloov lawm. Qhov hloov pauv no saib raws li tej ntaub ntawv uas xa tuaj ntawm koj tus kws kho hniav ntsig txog koj qhov mob hniav tam sim no los sis ua raws li cov lus qhia.
- 04 **Peb cov cai qhia tias twb tau tso cai rau, los sis txais tas cov kev pab zoo sib xws yav dhau los twb raug pom zoo, rau them rau, los sis ua tiav lawm.
