Caries Risk Assessment Procedure Codes and New Adjudication Reason Codes

New Caries Risk Assessment (CRA) procedure codes are available to participating providers in the 11 specified counties during the pilot phase of the Dental Transformation Initiative (DTI) Domain 2 effort. The new procedure codes and their descriptions are below:

Procedure Code	Description	
D0601	Caries Risk Assessment, low risk	
D0602	Caries Risk Assessment, moderate risk	
D0603	Caries Risk Assessment, high risk	
D1310	Nutritional Counseling	
D1354	Interim Caries Arresting Medicament	
D9993	Motivational Interview

As a result of the new procedure codes, several new Adjudication Reason Codes (ARCs) have been created. The new codes and their descriptions are below:

- **320C** Rendering provider must be CRA certified and opt-in.
- 437 CRA procedure code must be performed in a DTI domain 2 county.
- **437A** CRA procedure code must have the same dates of service and be billed on the same claim.
- **438A** CRA procedure code is allowable once every 6 months for low risk patients.

438B Procedure D1354 is allowable once every 6 months when CRA includes high risk procedure D0603.

- **438C** CRA procedure code is allowable once every 4 months for moderate risk patients.
- 438D CRA procedure code is allowable once every 3 months for high risk patients.
- 438E Additional services are allowable in conjunction with CRA procedure codes.
- **439** Payment denied due to lack of DTI domain 2 Funding.

In addition, policy code 38 has been modified to read as follows:

38 Payment disallowed. Procedure(s) are non-benefit for RDHAP/RDHEF/RDH
