### **Tips for Written Provider Correspondence!**

The Medi-Cal Dental Program would like to share helpful correspondence tips to expedite processing and turnaround times for written provider inquiries. Written correspondence should include specific information that pertains to the inquiry or request. Provider information such as legal name, business name, business address, phone number, National Provider Identifier (NPI) and an original signature should also be included.

For Explanation of Benefits (EOB) inquiries, please mail a letter to the Denti-Cal Provider Correspondence address shown below and include the following information:

- The issue date of the EOB and/or the check number
- Explanation of the request or questions related to an EOB
- Identify whether or not an EOB was received or misplaced, or if you are requesting duplicate copies.\*

\*Lost or misplaced EOBs are reprinted at a cost of ten cents (\$.10) per page and an additional cost for labor/research of ten dollars (\$10.00) per hour. If the US Postal Service lost the EOB, the EOB will be issued at no cost to the provider.

For a request to stop payment or reissue a lost or stolen Medi-Cal Dental Program payment check, please mail a letter with original signature to Denti-Cal Provider Correspondence. Two of the following three account identifiers must be included in the correspondence:

- Check number
- Check date
- Check amount

Denti-Cal Provider Correspondence will notify the provider with written confirmation of the resolution no later than 20 business days from the receipt of the written inquiry. Missing information or absence of original signature will delay processing.

## First Tooth or First Birthday Initial Dental Checkup

No child is too young for good oral health. Undetected and untreated tooth decay can lead to infection, loss of teeth, and expensive and preventable emergency and restorative procedures at a very early age. Establishing a regular source of care and treating Medi-Cal Dental's youngest beneficiaries gives providers the opportunity to discuss the importance of preventive dental care with parents, and allows them to detect early childhood caries and determine fluoride needs.

The American Dental Association, the American Academy of Pediatric Dentistry, and the American Academy of Pediatrics recommend seeing young children upon the eruption of their first tooth, and no later than their first birthday.

As providers, you have the opportunity to establish the foundation of a child's oral health and provide a valuable service to your community. Educating parents on their child's oral health needs is an invaluable part of their first visit to the dentist. This first visit is the perfect opportunity to demonstrate how to properly clean the child's teeth, establish the routine of visiting a dentist, and advise parents on the adverse effects of unhealthy dietary habits. Although the initial dental examination of a child may not involve many teeth and can be done very quickly, the early detection of early childhood caries can result in a better dental experience for young children, free from the pain and anxiety a child would face during more invasive procedures.

Parents should be advised that if they give their baby a bottle at bedtime, they should only give water and gently wipe the baby's gums with a washcloth until the first tooth arrives. After the first tooth, they should brush baby teeth at least twice a day with an age-appropriate toothbrush using a "smear" of fluoridated toothpaste.

To facilitate the providers in monitoring the oral health and rendering this much needed service, Medi-Cal Dental offers a benefit for children under the age of three. Please refer to <u>Bulletin Volume 33, #5</u>.
